Jiant Jenga Tournament Rules

Team Rules

1. Participant order of play is selected prior to the start of the match and stays the same for duration of the match.
2. Using one hand only, take one block each turn from any tower level except the topmost complete level.
3. Place the block on the topmost level of the tower. If the tower stays in place for 10 seconds, the team scores a point for the block.
4. The next player's turn begins after the 10 seconds has been counted.
5. You may begin to move a block to test it, but it must be moved back into the original position if it will not be placed at the top.
6. The game ends when a player's move causes the tower to fall or any block to fall off the tower. That block will not score a point.

Tournament Speed Round

The tournament will start with each team participating in the speed round. For the speed round the team will use the Jenga Blocks to build the tallest standing tower possible in 5 minutes. Winning team will be the team with the tallest tower at the end of 5 minutes. Winning team members will receive a medal.

Tournament Bracket

After the speed round, teams will be placed into a tournament bracket and will compete against another team. The winning team from each match moves on to the next round. This will be a single elimination tournament with trophies awarded to 1st, 2nd, and 3rd place teams.

Costume Contest

Teams are asked to wear costumes relating to this year's event theme of "Carnival/Jamboree." At the beginning of the tournament a team photo will be taken for each team and will be posted online. Each team will have a donation jug where spectators, family, and friends can donate money to vote for the team they like best. A trophy will be awarded to the team that raises the most money for the Costume Contest.
